IN 2015, OUR ASTRONOMERS PUBLISHED ON AVERAGE ONE PAPER PER WEEK, AND THEY REGULARLY PARTICIPATE IN MAJOR ASTRONOMICAL MISSIONS (INCLUDING THE NEW HORIZONS MISSION TO PLUTO AND THE KUIPER BELT) AND FACILITIES AND SCIENCE REVIEWS. IN 2015, WE BROUGHT LOWELL'S 4.3-METER DISCOVERY CHANNEL TELESCOPE (DCT) INTO FULL OPERATIONS, DELIVERING 297 SCIENCE NIGHTS TO ASTRONOMERS FROM OUR OWN STAFF AND FROM OUR PARTNERS'.
