I hope everyone is enjoying a pleasant Veterans' Day holiday. I grew up having an ex-Navy dad and enjoy working with our colleagues at the US Naval Observatory and the Naval Research Laboratory. ### **General notes**

### **Section 17**

- Bob informed me earlier this week that a possible mark-up on S. 242 scheduled for next week will *not* happen due to post-election turbulence. I find this unsurprising. ### **Astronomy Discovery Center**

- No change from two weeks ago. We continue to work on permits and content planning.

### **Lowell operational status**

- As you no doubt know, Covid numbers in Arizona and in our community are spiking rapidly, and now that the wave has been underway for a few weeks, hospitalizations have also begun this week to rise steeply. The summer wave

lasted three months almost to the day from start of steep rise to end of steep decline; I'm therefore planning for least four for the current wave, under the assumption it will be lengthened by holiday travel and mingling and general virus fatigue. Lowell will remain in Phase 1 programming while this plays out, meaning 3-6 groups of 10 or fewer per evening for distanced outdoor viewing when weather permits. Lowell-related traffic on Santa Fe and nearby streets should remain light.

- The most recent reports from Southwest Protective Services indicate general tranquility at the Mars Hill overlook. Mostly it has been occasionally telling folks to turn music down or not to park partially in the travel lanes. We will be reducing our 7 nights/week presence after this week to 2-3 nights/week. I'll keep you posted on how things seem after that.

If the current Covid wave indeed lasts four months, it will then be March, with the days lengthening rapidly and an ever-fickle Flagstaff spring on the way...and perhaps a vaccine in the offing. Maybe at that point the world will be brighter in multiple ways. I hope everyone is hanging in there and staying well.
